Day-of entries may be limited to accommodate short daylight hours

All dogs must be on leash. Please clean up after your dogs.

Directions to Trial: Take HWY 395 to Gardnerville. At the traffic signal at HWY 395 & Waterloo Lane turn Right onto Waterloo if coming from South, Left if coming from North. Street name turns into Toler, then Fish Spring Road. Go approx. 5 ½ miles to Windmill Road, turn Left on Windmill and go ¾ mile to ranch at the corner of Windmill & Shena Terrace. Turn Right on Shena to ranch entrance just past the 1st house on the right. Signs will be posted.
